



SAVE KOREAN DOGS WAIVER AND RELEASE OF LIABILITY

In return for being allowed to participate in **Save Korean Dogs USA Foundation, Inc.** and **Save Korean Dogs Sanctuary** (Korean Entity) volunteer activities, including any activities incidental to such participation (hereinafter, "Volunteer Activities"), the undersigned agrees to and acknowledges the following:

- 1. I am at least 18 years of age;
- 2. My involvement and or participation in Volunteer Activities is voluntary;
- 3. My involvement and or participation in Volunteer Activities poses significant personal risk including danger, bodily injury, emotional stress, or death;
- 4. My participation in Volunteer Activities may include caring for rescued dogs at the Sanctuary in South Korea, activities associated with the rescue of dogs from dog meat farms and dog slaughterhouses in South Korea, the transportation of dogs in South Korea and the United States, driving to and from fundraising activities or special events in South Korea and the United States, or any other Volunteer Activities in South Korea and the United States;
- 5. The potential for risk and danger may not be obvious or reasonably foreseeable;
- 6. I do not have any medical conditions or limitations that will affect my ability to participate in Volunteer Activities as described herein;
- 7. I understand that SKD takes no direct or indirect legal or financial responsibility for my personal safety or well-being while I am participating in Volunteer Activities;
- 8. I agree to assume all risk associated with participating in Volunteer Activities;
- 9. I agree to be solely responsible for all my expenses as a result of bodily injury, emotional injury, or property damage as a result of my participation in Volunteer Activities;

I further agree to release, indemnify, and hold harmless **Save Korean Dogs USA Foundation, Inc., Save Korean Dogs Sanctuary** (Korean Entity) and its directors, officers, employees, subcontractors, sponsors, agents, and affiliates (hereinafter, "SKD") from all present and future claims that may be made by me, my family, my estate, my heirs, or assigns for any and all damages including property damage, personal injury, or wrongful death arising as a result of my participation in Volunteer Activities wherever, whenever, or however they may occur. I also acknowledge that SKD has not arranged and does not carry insurance of any kind for my benefit or that of a Volunteer.

Moreover, I understand that this **WAIVER AND RELEASE OF LIABILITY** is intended to be as broad and inclusive as permitted by the laws of the region, state, and country in which the Volunteer Activities take place and I agree that if any portion of this **WAIVER AND RELEASE OF LIABILITY** is invalid or determined to be unenforceable, the remainder will continue in full force and effect.
